Is Georgia a good state to install solar panels?

With higher than average electricity prices and abundant sunshine, Georgia's a pretty great state for solar energy. It may not have the best local solar incentives, but as a Georgian, you can still take advantage of solar's most valuable incentive, the Federal Tax Credit. Here's what you should know about installing solar panels in the Peach State.

How much does a solar system cost in Georgia?

In Georgia, you'll need a 12.35 kW system to match the average electric bill. It'll cost you around \$22,192 after the federal tax credit. As long as your federal tax bill is high enough, you can take advantage of the federal investment tax credit (ITC). Compare multiple offers and save up to 20%

Does Georgia have a solar rebate program?

As of January, Georgia doesn't have any local incentives or rebate programs. However, Georgia Power will buy back the excess energy a solar panel system creates at a rate less than the retail cost of energy.

How much does a solar system tax credit cost in Georgia?

Given the average solar system cost of \$36,190 in Georgia, the 30% credit usually comes out to \$10,857. You can save that much on your tax bill if you owe enough to cover the credit, which can effectively bring down the cost of your system. Any unused credit can be rolled over to four additional tax years for a total of five years.

How much does a 5 kilowatt solar installation cost in Georgia?

Currently, the average price of 5-kilowatt solar installation in Georgia is between \$13,500 and \$12,733. That is the price before you claim the 30% federal tax credit. After the tax credit, the price comes down to about \$9,423, which equals approximately \$2.55 per watt.
